INSTRUCTIONS TO BUYERS

SCRUMPTIOUS PAWS KENNEL is dedicated to the improvement of the French bulldog breed. The intent of this contract is to assure that the DOGS produced from this kennel will receive appropriate care and will be protected from indiscriminate breeding, so that the outstanding qualities of health and temperament are enhanced. It is to be recognized that this French bulldog puppy represents many years of careful breeding and is considered to be of extreme value both to the breeder and to the buyer.

DEPOSITS:

Because of concerns with money orders, transfers and out of town/country checks, we only accept initial deposits made by PayPal or Amazon Payments through our store, Paws 2 Shop, at www.ScrumptiousPaws.com or, if you are in the Las Vegas area and making deposit in person, by cash. Buyer will receive emailed instructions on how to make online payment of the deposit at our website. If not received, please send an email to ScrumptTheFrenchie@ScrumptiousPaws.com to request the instructions are resent. This deposit will be applied to the total purchase price of a pet quality puppy as detailed within this agreement. Breeder must provide buyer with a pet quality puppy within 12 calendar months, or this deposit will be repaid to buyer in full. If the buyer making this deposit decides after completing this contract and sending a deposit that they do NOT want a puppy within 12 calendar months, this deposit will be retained by breeder.

BALANCE:

The remaining balance owed for the puppy must be paid in full at or before the time of the first scheduled pick up of the puppy. Payment can be made by a certified check (if drawn on a US bank), PayPal (via our website) or cash in person.

COMPLETING OUR CONTRACT:

Print (2) two copies of this contract and complete all areas. If not applicable, notate as "N/A", initial where indicated, and sign and date on the final page. **COMPLETE BOTH COPIES.** Completed contracts can be sent via Certified Mail to: Sonny Olson-Long, Scrumptious Paws, 1930 Village Center Circle, Suite 3-344, Las Vegas, NV 89134. Breeder will sign and initial both copies and return a fully executed agreement to the buyer and retain one for their records. Documents must carry original, non-digital signatures unless originating with the breeder via an e-signature interface. Photocopies or PDF documents are not acceptable. The buyer must show the breeder or person delivering the puppy (if nanny service is used) their fully executed copy of the agreement when the puppy is picked up or the puppy will not be released by the deliverer. Buyer is encouraged to keep a copy of their contract on file for the life of this DOG.

COMMUNICATION:

Scrumptious Paws wants to be able to provide top-end service so we ask that if any questions or concerns arise to please submit them via email so we can address to these concerns and document the inquiry. We will reach out to respond to the inquiry as quickly as possible and will transcribe conversations that may occur via telephone and/or text messages as reply emails for documentation purposes. We request a reply email with acknowledgment of receipt so we know documentation was received by the buyer if this occurs.

THE DOG:

Being sold is a pet-quality French bulldog born on Thursday, December 1, 2016 described in the table below (hereafter known as 'DOG'). BUYER agrees that this DOG will carry the ScrumptiousPaws prefix in its registered name.

Microchip has been or will be implanted by the time of delivery, and appropriate documents for Microchip registration transfer will be included with the care package to accompany the DOG on delivery.

Registration and Non Encumbrances Clause

The BREEDER guarantees this animal to be purebred and registered or registerable with the American Kennel Club, unless otherwise specified herein, and to be free of any liens or encumbrances resulting from terms of the stud contract, veterinary fees, leases or co-ownerships.

Non Breeding/Limited Registration Clause

BUYER agrees that this DOG has been purchased as a PET/COMPANION animal without any right to or expectation of breeding said animal. This DOG shall be spayed or neutered on or before eight months of age, if DOG has not already been altered before placement. BUYER understands that if this DOG has been sold with "Limited AKC Registration" and that this means that should a litter be produced from this DOG, the resulting puppies WILL NOT be eligible for AKC registration. Puppies produced by this DOG, whether sired or whelped, will become the property of the BREEDERS, and the BREEDER shall pursue damages in the amount of not less than \$10,000 for pain and suffering incurred as a result of this breeding. The BUYER will pay any and all court costs and lawyer fees associated with enforcing this clause.

HEALTH:

BREEDER has followed the National Breed Club Guidelines and used the Kennel Club health schemes and certification to ensure that the sire and dam are sound breeding stock. The DOG has been reared in a home environment and BREEDER believes that the DOG is healthy and in good condition without exception. The BREEDER has inquired of the BUYER his or her past experience with dogs and with this particular dog breed and on the basis of the information received is willing to place a DOG with the BUYER. The BUYER attests that he or she has not been banned from keeping a DOG or any other animal by any legal court. The BREEDER has pointed out to the BUYER the main conditions the breed is prone to and the health schemes followed to reduce the risk of such conditions. Every DOG is

an individual and the BREEDER cannot be held responsible should conditions, genetic or otherwise, develop later in life except as specifically defined within this agreement.

The DOG will be examined by BUYER's licensed veterinarian within 72 hours of receipt for a thorough check up. If the veterinarian deems this DOG to be unhealthy, and by which, makes the DOG unfit for sale, the following remedies may be sought:

- BUYER may return DOG to BREEDER for a full refund of purchase price provided the DOG is returned in the same condition as when it was sold, and within three days of veterinary visit,
- BUYER may choose to obtain veterinary treatment for said puppy. BREEDER reserves the right to obtain a written diagnosis of this DOG's diagnosis from BUYER's veterinarian, and to have their own veterinarian provides a second opinion on said diagnosis, before paying any incurred veterinary costs. In some cases, BREEDER may require BUYER to obtain a secondary diagnostic opinion from a secondary consulting veterinarian or veterinarian specialist in BUYER's region. BREEDER will cover cost of this secondary diagnosis. If BREEDER's vet and/or secondary veterinary specialist are in agreement regarding treatment this DOG requires, BREEDER will cover cost of said treatment up to but not exceeding purchase price of said DOG.

The BREEDER will not pay expenses incurred in the return of a DOG nor accept any claim for distress caused by the return.

Hereditary Illness Guarantee

This DOG is guaranteed against any serious, life threatening genetic defects till they are 1 year of age. If a life threatening genetic defect (i.e.; grade 4 or higher heart murmur, liver shunt, Von Willebrand disease, severe megaesophagus, etc) occurs within that time frame, the BUYER will be given another puppy of equal value or receive a refund of veterinary expenses associated with this condition up to the purchase price of the puppy. This refund or replacement shall be carried out at the BREEDER's discretion, once a letter from the diagnosing vet is provided. A second opinion will be obtained at the BREEDER's expense at a vet of the BREEDER's choosing and permission to speak with that vet will be provided prior to paying any vet consult bill. Hereditary allergies, elongated soft palate, parasites, stenotic nares, hemi vertebrae, malformed or butterfly vertebrae or accidents & illnesses of a non-hereditary nature are not included in this guarantee. The BREEDER is not responsible for veterinary charges other than those specifically identified within this agreement once this Agreement has been signed.

CARE & TREATMENT:

BREEDER is placing the above described DOG with BUYER as a companion DOG and family member. BUYER agrees that the DOG will not be used as a guard DOG, or for any purpose other than as a companion and friend to BUYER's family. The DOG will be kept under appropriate control and will not be neglected or maltreated in any way. BUYER agrees to provide this animal with a healthy, clean, safe home environment. If the DOG is found to be living in an unsafe, unhealthy environment, and/or its life is in jeopardy, deemed by BREEDERs and/or their agents, all ownership rights revert back to the BREEDER immediately. Conditions covered by this clause include but are not limited to malnutrition, neglect, abuse, and lack of adequate shelter or veterinary care. At no time will the DOG be left exposed to the outside elements (wind, rain, heat, or cold) or left outside when no one is home. This DOG will not be allowed to run at large and will be kept leashed or secured in a yard at all times when outdoors. The BUYER agrees that they will pay any and all court costs and lawyer fees associated with enforcing this clause. Additionally BUYER agrees to the following:

The Environment:

BUYER agrees that the DOG will be kept in appropriate conditions for its welfare and health. BUYER agrees that this DOG will be given extensive house privileges; i.e. sleep inside the house, be allowed freedom of the house when the family is home, and will NOT be restricted to the yard at any time. BUYER agrees to provide the DOG with fresh water, wholesome DOG food, adequate outdoor exercise, affection and shelter. Where applicable, BUYER will provide a secure fenced yard, with ample room for outdoor exercise. If fencing needs repair or modification in order to ensure the safety and well-being of the DOG, BUYER agrees to make any necessary repairs prior to allowing DOG

access to the yard. BUYER agrees to maintain the security of the fencing in the future to further secure the DOG. BUYER understands that gardeners, pool men, contractors and utility workers are not responsible for the safety of the DOG; therefore DOG must be kept indoors when workmen have access to the yard. BUYER agrees to keep the DOG indoors or in a safe and secure environment on holidays such as July 4th and New Year's Eve, as many DOGs are sensitive to and scared of loud noises.

Obedience Training:

BUYER agrees to provide obedience training for the DOG at their cost. BUYER agrees that if the training is not complete on any DOG being returned to BREEDER, BUYER will be financially responsible for the cost to complete training. Any behavioral issues (i.e., biting, destruction, escapism, fearfulness, dominance) that might lead to abandonment of the DOG, BUYER agrees to contact the obedience trainer as well as Scrumptious Paws and to follow the recommendation in resolving any issues as an effort to maintain custody of the DOG.

Identification:

BUYER agrees that the DOG WILL wear an identification tag with BUYER's current telephone number at all times. BUYER also agrees to update microchip company registration with any changes to BUYER's contact information with 30 days of change. BUYER understands that the identification tag is not a secure restraint and agrees that they will not walk the DOG with the leash attached to the DOG's identification tag.

Leash, Collar, & Crating:

BUYER will walk the DOG on a leash when on public streets or in parks or other unfenced areas, and will not allow the DOG to roam free unsupervised. The DOG will be walked using a slip or choke collar, martingale collar, or harness. The DOG will NEVER be tied up on BUYER's property or elsewhere. BUYER understands that restraining a DOG by tying it to a fixed post or wire run is unsafe and may cause theft of the DOG, unpredictable behavior and random aggression. BUYER will not leave the DOG crated and/or otherwise confined for extended periods of time (more than 5 hours).

Transportation:

DOG will be properly restrained, preferably using either a secured crate or seat harness when transported in any vehicle. DOG will never be transported in the back of an open vehicle or pick-up truck. DOG will not be allowed to ride with their head outside the window of a moving vehicle.

Lost DOG:

BUYER agrees to make an immediate and serious effort to find the DOG if it becomes lost, by:

- filing lost reports with the local police, animal control authorities, animal shelters, SPCAs and local veterinarians and pet stores,
- post lost DOG signs
- place lost DOG ads in BUYER's local paper
- contact BREEDER for additional support and advice

BUYER authorizes the DOG, if lost/found to be immediately released to Sonny Olson-Long or her agent in the event I cannot be reached for immediate reclaim of the DOG.

Furthermore, if the DOG gets returned to BREEDER, BUYER understands that if the loss was the result of negligence or failure to comply with the covenants of this Agreement, BREEDER reserves the right not to return the DOG and to place into a new home, without issuing any refund.

Veterinary Care:

The BUYER assumes all responsibility for the day-to-day health and temperament of this DOG, and agrees that the DOG will receive all necessary veterinary care to maintain its physical good health and keep all vaccinations current including but not limited to Rabies, Distemper/Parvo (DHLPP), and Bordetella. BUYER also agrees that the DOG will

receive parasite preventative medication to protect against heartworm, fleas, and ticks if present and/or prevalent where the DOG will reside. BUYER agrees to provide the best available care to the DOG in a timely manner. Any veterinary problems that may arise, including serious illness requiring emergency care or surgery is BUYER's responsibility and BUYER is responsible for all related costs. BREEDER guarantees that all shots and deworming are current and have been or will be received as indicated in the table below.

BUYER agrees that no alteration will be made to the animal's appearance (i.e., docking of ears) unless medically necessary.

Euthanasia:

BUYER agrees they may not euthanize the DOG except in the case of the DOG's terminal illness or injury, or old age accompanied by pain and suffering and in that case, the euthanasia must be performed by a licensed veterinarian.

FINANCIAL CONSIDERATION:

The DOG described in the section above is being sold for the sum of \$_____USD. To secure the purchase of this DOG, BUYER agrees to make a non-refundable deposit of \$500.00 USD payable within 5 business days of when the agreement has been completed, signed, and returned to BREEDER by BUYER and email receipt of same has been sent to BUYER by BREEDER. BUYER understands that no agreement will be fully executed until deposited funds have cleared the BREEDER's bank. Once the BUYER has paid BREEDER a deposit of \$500.00 USD to secure and hold for purchase this DOG, the outstanding balance (\$_____USD) of the full purchase price is due on or before the first scheduled delivery date of _____, unless otherwise discussed and agreed to by both parties and documented via email. In the event that a nanny delivery is requested, BUYER agrees to submit request

via email and understands that puppy delivery will be made no earlier than 12 weeks of age and only after signing a Nanny Services Addendum and submitting an additional \$500 nanny services fee. The BUYER agrees that this DOG will remain the property of the BREEDER until payment in full for all services has been made.

Spay/Neuter:

DOG is being sold as a pet-quality DOG with no breeding rights. BUYER agrees to sign a Spay/Neuter Addendum with us to have the DOG spayed or neutered. BUYER agrees that BREEDER will retain all ownership and registration papers for this DOG until written proof of alteration has been provided to BREEDER in accordance with the Spay/Neuter Addendum accompanying this agreement. If no proof of alteration documentation has been provided to BREEDER by the time the DOG is one year of age, BREEDER retains right of repossession for breach of contract. Any and all costs to recover, including legal fees, will be the responsibility of the BUYER.

Return Policy:

If BUYER decided to not keep the DOG, BUYER hereby agrees to return the DOG to the BREEDER. Importantly, BUYER agrees to give the BREEDER ten working days to secure a kennel, and will provide safe and loving care of the DOG until it is returned. BUYER agrees to safely transport the DOG to the determined kennel or veterinarian facility, and will return any/all paperwork and supplies provided by the BREEDER at that time.

No Right to Transfer:

If at any time in the future you cannot continue to provide proper care for the DOG, you will not abandon, give or sell the DOG to another person, company, organization, medical research, pound or animal shelter. BUYER agrees to do one or more of the following:

- Obtain approval from the BREEDER to transfer the ownership of the DOG to a friend or relative. Rescue must approve the new BUYER who will be required to sign an agreement similar to this one.
- Agree to cover the costs to board DOG for an agreed-upon time, allowing the BREEDER to actively seek a new home and then relinquish the DOG to BREEDER when a home is found. Note: Boarding costs are around _____ per day.
- Return DOG to BREEDER.

Estate Provisions:

BUYER agrees to provide for care of the DOG in their will or estate if by no other means than specifying in writing that DOG is to be returned to the BREEDER in the event of BUYER's death.

Non-Placement Clause

BUYER agrees that, should he ever decide to part with this DOG, become incapable of caring for this DOG, or be forced to surrender ownership of this DOG, DOG shall be returned to BREEDER. BREEDER agrees to pay any shipping costs incurred as a result of return of this DOG, up to the amount of \$500 USD. BUYER must contact BREEDER by registered letter at the address provided at time of purchase stating their intent to relinquish ownership of this DOG. BREEDER shall have one week (seven days) to respond to this letter and arrange to either take possession of this DOG, or have alternate arrangements for care made for this DOG. If BUYER sells, trades, surrenders to a shelter or rescue group or gives away this DOG to any party, without first notifying BREEDER by registered letter as outlined above, and then obtaining express written permission from BREEDER by registered letter to do so, BREEDER shall pursue legal damages in an amount not less than \$10,000 for pain and suffering incurred as a result of this unwarranted transfer of custodianship. This penalty exists to emphasize the importance BREEDER places on this DOG's lifetime well being, and to insist on their rights to remain informed and involved in the choice of home for this DOG. The BUYER agrees that they will pay any and all court costs and lawyer fees associated with enforcing this.

Continuing Contact Clause

BUYER agrees to keep BREEDER informed of any changes of address and/or phone number during their ownership of this DOG.

Health Information Clause

BUYER agrees to keep BREEDER informed of any severe illnesses, loss, injury or death, which may affect this DOG. BUYER agrees that if for any reason hip or spinal x-rays are performed on this DOG, a copy will be provided to the BREEDER's veterinarian. BREEDER agrees to pay cost of x-ray copies and shipping of said copies to BREEDER's veterinarian.

Non Adherence to Contract Clause

The BUYER agrees that, should he not meet any and all terms of this agreement, the BREEDER may repossess this animal, after giving five days written notice. The BUYER agrees to pay any lawyers' fees, court costs, traveling and shipping expenses, and other miscellaneous expenses incurred by the BREEDER in repossessing this animal. Any legal matters pertaining to this DOG and between BREEDERS and BUYERS shall be carried out in BREEDER's jurisdiction of choice.

Right to Reclaim:

BUYER understands and agrees that the BREEDER reserves the right to reclaim DOG if any of the above conditions are not met to the satisfaction of the BREEDER. BUYER further understands and agrees that any expenses incurred by the BREEDER in exercising its rights under this provision will be paid by BUYER in addition to any liquidated damages required by other provisions of this Agreement.

Special Disclaimer:

All warranties with regard to DOG, including any implied warranty of merchantability and fitness for a particular purpose, where they are applicable, are hereby specifically disclaimed.

Release & Indemnification/No Liability:

BUYER hereby releases the BREEDER from any and all liability for personal injury, property damage, legal fees, or veterinary care, or any other expense or liability incurred by BUYER as a result of this adoption. BUYER agrees to indemnify the BREEDER from any and all such claims and to pay, without limitation, any costs related to such injury, damage, or liability, including, in the case of litigation, any attorneys fees incurred by the BREEDER in its defense.

Entire Agreement/Modification/Binding Effect:

This Agreement is the entire agreement between you and us, and supersedes any prior understandings between you and us with respect to the subject matter of this agreement. No modification of this Agreement will be valid unless in writing duly signed by both you and the BREEDER. This Agreement is binding upon you and BUYER's heirs, assigns, successors, personal representatives and executors.

Breach of Agreement/Liquidated Damages:

In the event that you do not comply with the terms of this Agreement, or the DOG is abused or neglected, we hold the right to recover the DOG from you upon demand, and the DOG will be surrendered to us immediately. In addition, without waiving any of our rights under this Agreement, if you do not surrender the DOG to us, you will owe us a payment in the amount of \$10,000.00 USD agreed between us as just and reasonable liquidated damages to compensate us for our costs and expenses in connection with BUYER's breach of this Agreement and we reserve our rights to reacquire the DOG.

Change of Contact Info:

Follow Up:

BUYER understands and agrees that the BREEDER is fully entitled to make follow-up visits or phone calls to ascertain that all of the covenants and clauses of this agreement are being satisfied. BUYER is obligated to cooperate with the BREEDER.

Spay/Neuter Addendum

Permanent ownership of this DOG is contingent upon BUYER’s compliance with this Addendum. Proof of spay/neuter must be received by the Scrumptious Paws within fourteen (14) days after the surgery. In the event that the DOG’s health does not allow this agreement to be honored, Scrumptious Paws must be provided with a statement from BUYER’s veterinarian that this DOG is not yet in physical or emotional condition for surgery.

Based upon the veterinarian’s evaluation of this DOG the Scrumptious Paws will contact the veterinarian and establish the earliest date that the procedure can be performed. BUYER will notify the Scrumptious Paws of this amendment in writing, at which time all other conditions of this agreement will apply and be enforced.

This is the responsibility of the BUYER, not the veterinarian, to ensure that Scrumptious Paws has received verification that the surgery has been performed.

Failure to comply with this amendment to the agreement by the date below, unless otherwise agreed to in writing, will be considered a breach of the Contract, and BUYER will transport this DOG back to Scrumptious Paws and will not be entitled to a refund. If BUYER does not return DOG, all legal avenues will be employed to enforce this agreement.

By my signature below, I agree to have this DOG spayed/neutered by no later than _____, and I understand that this spay/neuter agreement is an agreement that this DOG will not produce a litter of puppies either by purposeful breeding or by accidental breeding. The request and payment of \$500 must be received no later than fourteen (14) days before scheduled delivery date after the DOG reaches 12 weeks of age (February 23, 2017).

SCRUMPTIOUS PAWS WILL NOT PROVIDE AIR TRANSPORTATION OF ANY DOG YOUNGER THAN 12 WEEKS OF AGE.

Prior to travel, the DOG will be evaluated by a licensed veterinarian and if it is determined that the DOG is unfit for travel by air (in the cabin, with people), the BUYER will have the opportunity to select from the following options to receive the DOG:

Request ground transportation/delivery of DOG by agent of Scrumptious Paws’ choosing

In the event that the buyer selects to have the DOG delivered by a ground pet transportation agent of Scrumptious Paws’ choosing, the agent making delivery will require proof of purchase in the form of the counter-signed agreement. **If the BUYER does not provide this for the agent at the time that the DOG is scheduled for delivery, the transportation provider, acting as agent for Scrumptious Paws will not release the DOG.** In the event that there is no opportunity to reschedule delivery the DOG will be returned to Scrumptious Paws and arrangements will need to be made to reattempt delivery at additional cost.

Request release of DOG to pet transport agency of BUYER’s choosing,

In the event that the buyer selects to have the DOG delivered by a ground pet transportation agent of BUYER’s choosing, the BUYER must provide BREEDER with contact information regarding the agent who will receive the DOG on their behalf including their name, Company (if any), telephone number, and email address. Scrumptious Paws will contact the agent via email and cc the BUYER on all communications. The agent must present BUYER’s proof of purchase in the form of a photo-copy of this counter-signed addendum with the words “FOR PICKUP OF [DOG’s name] FROM SCRUMPTIOUS PAWS” under the signature line on this page and present photo ID for verification of identity. **If the transportation agent does not provide these items for Scrumptious Paws at the time that the DOG is scheduled for pickup, Scrumptious Paws will not release the DOG until presented.** In the event that the DOG is not released to the agent and there is no opportunity to reschedule pickup, the DOG will remain with Scrumptious Paws and arrangements will need to be made to reattempt pickup at a later date. If BUYER selects this option, a refund of \$425 will be provided to offset the cost for the veterinary clearance appointment and time communicating with the BUYER’s transportation agent.

Receive a refund of the payment to Scrumptious Paws to provide delivery of the DOG

In the event that the buyer selects to pick up the dog directly from Scrumptious Paws in Las Vegas, NV, BUYER will receive a refund of delivery payment less 10% to cover travel clearance veterinarian appointment. All requirements for receipt of DOG will be required as outlined in the agreement.

BUYER understands that Scrumptious Paws will not be held liable or responsible for any delays in delivery due to factors outside their immediate control, including but not limited to delivery agent schedules, forces of nature, traffic, and/or miscommunications between agent and BUYER and others not specifically listed herein. BUYER understands that any language within this addendum that is unclear to the BUYER, the BUYER will ask for explanation prior to signing, as applying signature to this document constitutes agreement with all statements and adherence of the same and understands that failure to request explanation will not release them from all any conditions of this agreement to be applied and be enforced.
